



- Select the Entity in the Grid and click on Order a Certificate of Status



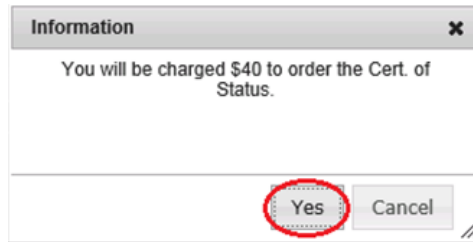
