Entity Types

BUSINESS NAMES - Entities are registered under The Business Names Registration Act and The Partnership Act.	
SOLE PROPRIETORSHIP	Sole registrant is an individual.
PARTNERSHIP	Registration contains two or more registrants.
OTHER PROP	Sole registrant is not an individual.
LIMITED PARTNERSHIP	A Limited Partnership consists of “General Partner(s)” and Limited Partner(s). Only General Partner information is included on File Summaries. Contact the Companies Office to inquire on how to obtain a list of Limited Partners. More information about these entities is available under Part II of The Partnership Act.
NON PARTNERSHIP	Registration contains two or more registrants, however, a letter has been provided stating that they are not a partnership.
TRUST	Sole registrant is a family trust.
EXTRA PROVINCIAL LLP	The Limited Liability Partnership formulated in another province or territory registered to carry on business in Manitoba.
EXTRA PROVINCIAL LIMITED PARTNERSHIP	The Limited Partnership formulated in another province or territory registered to carry on business in Manitoba. Only General Partner information is included on File Summaries. Information about Limited Partners must be obtained from the home jurisdiction.
MB LLP	Manitoba Limited Liability Partnership. More information about these entities is available under Part III of The Partnership Act.

BUSINESS CORPORATIONS - Are corporations with share capital which are incorporated for profit. Entities are incorporated or registered under The Corporations Act.	
MB SHARE CORPORATION	Corporation incorporated under the laws of Manitoba.
EXTRA-PROVINCIAL - SHARE CORPORATION	Extra-provincial corporation incorporated in another province, territory or country registered to carry on business in Manitoba. Note: Pursuant to the New West Partnership Trade Agreement, information about Directors and Officers must be obtained from the home jurisdiction for corporations from British Columbia, Alberta and Saskatchewan.
FEDERAL- SHARE CORPORATION	Share capital federal corporation incorporated by Corporations Canada.
MB TRUST/LOAN CORPORATION	Manitoba trust and loan corporation. More information about these entities is available under Part XXIV of the Corporations Act.
EXTRA PROVINCIAL - TRUST/LOAN CORPORATION	Extra-provincial trust and loan corporation incorporated in another province, territory or country registered to carry on business in Manitoba.
FEDERAL - TRUST/LOAN CORPORATION	Federal trust and loan corporation incorporated under the laws of the Canada.
MB SPECIAL SHARE	Manitoba corporation incorporated by an Act of the Manitoba Legislature.
MB INSURANCE CORPORATION	Manitoba insurance corporation. More information about these entities is available under Part XXIII of The Corporations Act.
MB COMMUNITY DEVELOPMENT CORPORATION	Manitoba community development corporation. More information about these entities is available under Part XXI of The Corporations Act.
MB RURAL DEVELOPMENT BOND CORPORATION	Rural Development Bond Corporations were incorporated under The Corporations Act pursuant to Part 2 of The Community Development Bonds Act (formerly The Rural Development Bonds Act). These entities are all inactive as The Community Developments Bonds Act is no longer active and the legislation will be repealed.
EXTRA PROVINCIAL CO-OP	Extra-provincial cooperative incorporated in another province, territory or country. Note: Pursuant to the New West Partnership Trade Agreement, information about Directors and Officers must be obtained from the home jurisdiction for cooperatives from British Columbia, Alberta and Saskatchewan.
FEDERAL CO-OP	Federal cooperative incorporated under the laws of the Canada.

NON-PROFIT CORPORATIONS - Are non-share corporations incorporated where the undertaking to one that is only of a patriotic, religious, philanthropic, charitable, educational, agricultural, scientific, literary, historical, artistic, social, professional, fraternal, sporting or athletic nature or the like. Entities are incorporated or registered under The Corporations Act.	
MB NON SHARE CORPORATION	Corporation incorporated under the laws of Manitoba.
EP NONSHARE CORPORATION	Extra-provincial corporation incorporated in another province, territory or country registered to carry on business in Manitoba.
FD NON SHARE CORPORATION	Federal corporation incorporated by Corporations Canada registered to carry on business in Manitoba.
MB SPECIAL NON SHARE	Manitoba corporation incorporated by an Act of the Manitoba Legislature.
EP NON SHARE CO-OP	Extra-provincial cooperative incorporated in another province, territory or country registered to carry on business in Manitoba.
MB REGIONAL DEVELOPMENT CORPORATION	Manitoba regional development corporation. More information about these entities is available under s. 267(2) of The Corporations Act.

COOPERATIVES - Entities are incorporated under The Cooperatives Act.	
MB SHARE CO-OP	Manitoba "business" cooperative.
MB NON-SHARE CO-OP	Manitoba non-profit (non-share) cooperative.

CREDIT UNIONS - Entities are incorporated under The Credit Unions and Caisses Populaires Act.	
MANITOBA CREDIT UNION/CAISSE POPULAIRE	MB Credit Union/Caisse Populaire. Questions regarding these entities should be referred to The Financial Institutions Regulations Branch.

NAME NOTATIONS - Entities are registered under The Corporations Act	
NAME NOTATION	A Name Notation is used by non-profit groups, which are not incorporated. It notes the name of the group or organization on our records.

SOCIETIES	
MB SOCIETY	Manitoba corporation incorporated under The Religious Societies Lands Act or the Ukrainian Catholic Parishes Incorporation Act. As there is very little information on record for these entities, File Summaries are not available. Contact the Companies Office for copies of the incorporating resolutions.

STATUS

STATUS	DEFINITION
Active	An entity that is up-to-date in filing its Annual Return or Renewal with the Companies Office.
Active (Continued)	A corporation that has continued under the laws of Manitoba from another jurisdiction.
Active (New Amalgamated)	The corporation formed as the result of an amalgamation. The File Summary has a section providing information on the "predecessor" corporations that were involved in the amalgamation.
Active (New Name)	The entity changed its name.
Active (Restored)	Non-Manitoba corporation that was inactive and has restored its registration.
Active (Revived)	Manitoba corporation that was inactive and has been revived.
Inactive (Amalgamated)	The corporation that has amalgamated. The File Summary has a section providing information on the "successor" corporation.
Inactive (Canc. by Branch)	The registration of a Non-Manitoba corporation has been cancelled for failure to file Annual Returns for two consecutive years.
Inactive (Canc. by Request)	The registration of a Non-Manitoba corporation has been cancelled by request.
Inactive (Canc. Certificate)	The registration of a Non-Manitoba corporation has been cancelled by filing an Application for Cancellation of Registration.
Inactive (Cancelled)	The registration of a Non-Manitoba corporation has been cancelled for failure to comply with the Corporations Act.
Inactive (Discontinued)	Manitoba corporation has continued into another jurisdiction and issued a Certificate of Discontinuance in Manitoba.
Inactive (Diss. by Branch)	Manitoba corporation has been dissolved for failure to file Annual Returns for two consecutive years.
Inactive (Diss. by Request)	Manitoba corporation has been dissolved by request.
Inactive (Diss. Certificate)	Manitoba corporation has been dissolved by filing Articles of Dissolution.
Inactive (Dissolved)	Business Registration has been dissolved.
Inactive (Expired)	Business Registration is valid for three years. The registration expires if the business does not renew.
Default	Corporation is in default of filing its last year's annual return with the Companies Office.
Notice	Corporation has been given notice to file their last two year's of annual returns with the Companies Office or the corporation is subject to be dissolved/cancelled in Manitoba under the Corporations Act.
